Proposal: Replacement dwelling

Location: Waves Edge, Challaborough, TQ7 4JB

I write to advise the Planning Inspectorate that Bigbury Parish Councillors considered view on this proposal has not changed and in line with objections already submitted on July 26th 2016, August 24th 2016 and January 12th 2017, the Council confirm their unanimous objection to the above planning application in respect of Waves Edge, Road to Highfield, Challaborough, TQ7 4JB.

The Parish Council also note that the District Council has consistently objected to this application and that the last submission from South Hams came after a site visit had been undertaken.

The Parish Council consider:

- 1) Changing the building from a bungalow to a two storey building is, as stated before, in-appropriate if constructed on the same ground level.
- 2) Increasing the mass by two thirds is, as stated before, also inconsistent with the site and the other properties on the building line.
- 3) The increased height of the proposed development to be unacceptable and will result in a loss of amenity in respect of the properties to the rear of Waves Edge.

The Parish Council also consider, as previously suggested in earlier responses, that should the property be set lower into the site, further away from the access road and closer to the coastal path, then both 1), and 2) above would have less impact on the existing amenity by maintaining the height of the existing ridge line.

This suggestion does not seem to have been considered by the appellants who continue to pursue the path that has been frequently rejected

As previously stated the Parish Councillors acknowledge the need for properties to be developed and enhanced and having visited this site consider there is sufficient scope, and available land on the plot itself, to reposition a new build (existing property to be demolished)

To refer to the views of the District Council the development would be by reason of its height and impact upon the South West Coastal Path be an incongruous feature out of keeping with, and harmful to, the character of both the settlement itself and the South Devon AONB.

To conclude the Parish Council have no grounds to alter their opinion and once again make a formal objection to this proposal; a view they hope the Planning Inspectorate will support.
