4.0 <u>Open session</u>

Resident A commented on the proposal to create a 'volunteer' list to ensure completion of low maintenance tasks around the parish. She suggested the creation of a 'Civic Day' where locals could gather and attend to such tasks as necessary. It was agreed to add this topic to the agenda of the March 2018 meeting.

Action Clerk

Resident A asked the Councillors if they were aware of a recent news article relating to the £2m pot of S106 money available for local projects. The Clerk confirmed the S106 fund allocation for Bigbury Parish Council was always shown on the monthly financial statements and Cllr. Rosevear indicated that S106 funding would also be discussed later in the meeting – Playpark agenda item.

Resident A made reference to the proposed demolition of the Bay café and comments can be found later in these minutes – agenda item 6c.

Resident B asked that the notice board in Bigbury Village be repaired as it was constantly blowing open. The Clerk confirmed that this had been discussed with Councillors a few days earlier and the intention was to replace it with a new one.

Action Clerk

Resident C stated the condition of the traffic mirror in St Ann's Chapel had deteriorated and there had been several road accidents since Christmas. Action was needed to accelerate its repair or replacement.

Action Clerk

Resident C asked what measures could be taken to ensure the grass in the playing field is cut more often and not left to grow unchecked.

Action Clerk

Resident D asked if the Council were supportive of him undertaking basic maintenance work on the Warren as he had received no response from the Parish from previous similar requests. The Clerk apologised that no response had been given.

The Chairman was supportive of work being carried out but pointed out the Warren was not owned by the Parish Council and that its future was not yet determined – South Hams were in discussion with the owners over a new lease agreement.

The Chairman indicated he would talk to SHDC in respect of this.

Resident E also raised the question of liability in the case of an accident and it was agreed the Clerk would discuss this topic with the Council's insurers.

Guidelines for insurance cover – simple 'Housekeeping' tasks in the Parish

Every individual task must have been subject to a risk assessment – this must be documented in advance and kept on record.

PPE (Personal Protective Equipment) should be made available to those undertaking the tasks. For example eye goggles, gloves and high visibility jackets.

The Parish Council should be satisfied those undertaking these simple 'housekeeping' tasks are capable of doing so

Both tasks and those undertaking them must be approved by the Parish Council ahead of any work being completed.

Only basic / simple 'housekeeping' tasks are covered

No insurance cover if the above guidelines are not followed.

5.0 <u>County Councillor's report</u>

C.Cllr. Gilbert was not present and no update was given.

6.0 <u>Planning applications and related matters:</u>

4066/17/HHO Long Easton – application for landscaping and engineering works within garden and entrance to property. This was a retrospective application and Cllr. Carson proposed it be supported. Cllr. Smith seconded the proposal and all Councillors were in support.

4120/17/FUL Land at Sx 663 471, East of the Pickwick Inn, St Ann's Chapel – Four new dwellings, vehicular access and public realm improvements.

The Chairman opened this topic for public discussion and resident F expressed concerns in respect of the lack of scale and general dimensions on the drawings adding that the site was being over-developed, with houses that were too high. Resident A also commented that this development was outside the scope of the Neighbourhood Plan, questioning whether it was needed at all.

The Councillors concluded that the lack of scale and dimensions, the fact that the development was set above the surrounding road levels, the over-development, the height of the properties and the demolition/re-building of surrounding walls and hedgerow provided sufficient grounds to object to the proposal. Cllr. Carson proposed the objection, Cllr. Case seconded the proposal, Cllr. Rosevear abstained from the vote (see declaration of interest) and the remaining Councillors voted in favour of objecting.

4383/17/PAD Bay Café Application for prior notification of proposed demolition.

The Chairman opened this topic for public discussion which focused on the fact that this application was submitted whilst the outcome of a challenge to the listing of the Bay Café as an Asset of Community Value was awaited as was a decision from a tribunal in respect of the planning application itself. This tribunal was not likely to be scheduled until April or May 2018.

Resident E raised concerns over the legality of the application on the basis that it should have been submitted by the Mortgagor.

Residents A and E encouraged all residents to voice an opinion on the South Hams District Council's planning portal.

Cllr. Rosevear proposed that the Council object to this application in the strongest possible terms. Cllr. Smith seconded the proposal and all Councillors unanimously agreed.

Clerk showed a new slide detailing \$106 funds held by SHDC - £97,578 for affordable housing projects and £26,882 for OSSR projects.

Precept year commencing April 1st 2018

The Councillors had met on Friday 5th January to review the precept for the forthcoming year and concluded that it should be set at £16,000, an increase of £3,500 over the current year. Cllr. Carson confirmed that normal council expenditure was being held at the current level but two specific projects had been included that made up the increase. These projects were a maintenance and repair programme for the Millennium Steps (£1,500) and a sum of money to be set aside for the Play Park project (£3,000). The impact of this was an increase of £7.80 per annum for Band D properties.

Resident C made reference to the fact that this increase was in excess of 20% and were the Council able to justify such an increase. Cllr.Carson confirmed the two projects were important for the local community. Cllr. Rosevear proposed the Precept of £16,000 be accepted, Cllr. Case seconded the proposal and all Councillors voted to accept the proposal.





Bigbury Parish Neighbourhood Plan

Community-led Housing Scheme

Andrew Kirby Architects have now prepared an initial scheme for the Holwell Farm site showing 12 dwellings (3 private and 9 affordable). This scheme was shown to the Steering Group at their last meeting and was also discussed with the landowners. We have suggested a few changes to the scheme to include two bungalows to replace two of the two storey houses. We have also asked the Architects to prepare some illustrative drawings to show the type of dwellings and possible appearance. When we have received these we will be arranging a community event to discuss the scheme and to obtain the views of parishioners. This will be one of many meeting to make sure that we have the continued support of the community. We want to avoid any unacceptable loss of views, privacy or other types of amenity to residents of neighbouring properties and we will ensure that those living close by are made aware of the proposals and given the opportunity to comment.

An Archaeological Assessment of the site is now being undertaken and the Archaeologists we are consulting with Historic England to ensure that this is carried out in accordance with their requirements.

Site Options and Assessment

AECOM Environmental Consultants are now actively engaged in carrying out an independent assessment of all of the sites available for development in the parish and hopefully we should be receiving their report in a few weeks time.

Strategic Environmental Assessment

AECOM are also now preparing a scoping report for the Strategic Environmental Assessment (SEA). This is the first stage of the assessment to obtain agreement from the District Council on the environmental issues that they need to consider. AECOM will then carry out an SEA of the draft Neighbourhood Plan to ensure that the draft plan does accord with environmental legislation.

List of Local Heritage Assets

The Steering Group have started preparing a draft list of local heritage assets based on our village studies and a tour of the parish. To date we have not received any responses to our request for parishioners to put forward their ideas for the local list. There are nomination forms and a box for comments in the Holywell Stores so that everybody can get involved in this process.

We have not as yet carried out our detailed studies of the villages with the help of the youth of the parish but have put out a request for parents/guardians to let me know if their children would like to get involved. We have had a very positive response but there are quite a few people who have not responded so far. The weather was not been ideal to carry out these studies and we are waiting for a spell of better weather, but hopefully these events will take place very soon.

Important Views and Vistas

We are also putting together a list of important views and vistas that we need to protect. Again, we would like the local community to become actively involved in this work and it would be great if people could send me photographs of views that they consider should be protected.

Draft Neighbourhood Plan

The text of the draft neighbourhood plan is almost complete and Karen Lawrence is now putting this into an attractive format to include plans and photographs. We will be carrying out consultations with various parties including South Hams District Council, Historic England, the AONB Unit and other statutory consultees but do need AECOM to complete their work before we can carry out a formal consultation with the community. However, we do hope to be in a position to consult with the community on the draft Neighbourhood Plan in the Spring.

Local Consideration Network

For those areas where legal designations as traffic sensitive cannot be made we are aware, as the highway authority, that early conversations and consultation on works would help reduce network disruption. We are therefore developing a secondary network of routes entitled 'local consideration'.

This is a network that will trigger a need for anyone planning works to discuss with local stakeholders at an early stage (i.e. at the point of noticing). The development of this network is ongoing, however, this network can be considered for areas where traffic sensitive designations do not apply.
