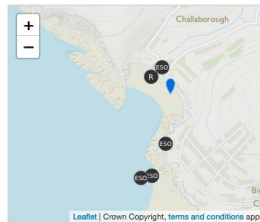

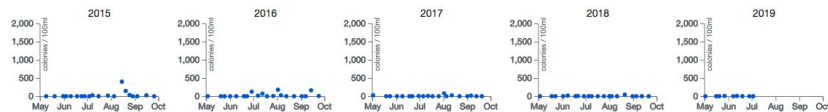

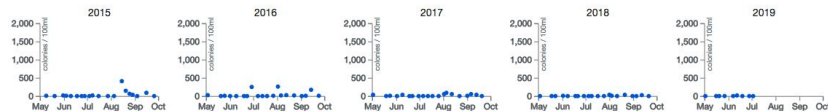

Intestinal Enterococci (IE)

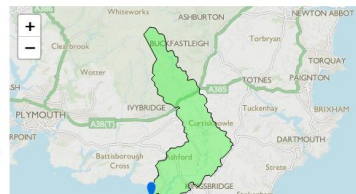


Escherichia coli (EC)



Catchment description

The catchment surrounding Challaborough is approximately 15,000 hectares. The Challaborough Stream is approximately two and a half kilometres (km) long and flows across the western side of the beach. The River Avon is approximately one and a half kilometres to the east. The River Avon and its major tributaries (the Bala Brook and the Glaze Brook) rise on south Dartmoor. The Avon flows for 37 kilometres through the Avon Reservoir, South Brent, Avonwick, Loddiswell and Aveton Gifford before reaching the estuary mouth at Bantham and Bigbury on Sea. As the river flows from the open moorland, it has created steep sided valleys with small enclosures mostly used for small scale livestock farming. The steep catchment means rain runs off rapidly into the many small streams that feed the River Avon. The estuary of the Avon is tidal up as far as the weir at Aveton Gifford, and like the other estuaries of South Devon, the original deep river valley has been flooded by sea level rise, to create a wide expanse of water. The catchment is mostly agricultural, with more than 50 farms.

To update you on the traffic lights between Fancy and Edmunston which is between Modbury and the River Erme.

You will have noticed they are still in place with little or no activity.

Unfortunately, when clearing the drains and ploughing back the edge in preparation for further work, it was found that the road edge had large cracks/structural damage and thereby classifies as a safety risk to traffic.

I regret to inform you that at present this inconvenience has no termination date and will require considerable structural work to allow the road to open as normal.

Please can you relay this e.mail to anyone within your communities whom might need to know and regularly uses the road for work or hospital etc.

Please can I draw your attention to the following:-

1: Folly Hill: There is a considerable amount of vegetation overflowing over the road surface coming down Folly Hill. Please can the parish council arrange for all the vegetation on the properties bordering the down side of the road, to be cut back considerably or else for the owners themselves to cut it back. Because of this overgrowth I notice that the traffic coming down the hill is well over the centre lines and also the yellow restriction lines are covered over. The worst offender is the National Trust land at Clematon Hill – in some places it is impossible to see the double yellow lines.

2: Also the same could be said for the bottom of the bank on the roadside of the car park and also Marine Drive. It is so bad that the access to the phone box is knee high to a donkey.

3: Can a solid line be put along the exit from the BoS car park - all too often traffic doesn't stop and comes straight out onto the road regardless of any traffic already on the road.

4: There are dotted lines on the Ringmore Drive/Parker Road junction but no dotted lines on the Cleveland Drive/Parker Road junction – these need to be painted across the Cleveland Drive entrances onto Parker Road identical to those at the Ringmore Drive junction.

5: Hedgebanks are not being cut back far enough in Bigbury on Sea – the worst one is on the Parker Road/Ringmore Drive junction. The exit from Ringmore Drive onto Parker Road is now extremely dangerous because the hedge is badly overhanging the road – in fact the yellow lines are not at all visible so it really needs cutting back by at least one to two feet.

AVON ESTUARY PATROL

Objectives of the Service

- To provide a safer and more secure environment for recreational use of the tidal waters by the general public
- To provide a means of recording and reporting back to the Owner, incidents of illegal fishing
- To provide a means of recording and reporting to SHDC and the Owner. incidents or risks of potential incidents likely to cause environmental harm
- To provide a suitable patrol boat* and qualified Warden* to uphold the byelaws covering the use of watercraft in the tidal area of the Avon Estuary

*** SHDC requires all small commercial craft operating within defined limits to obtain a local authority licence for both the vessel and the boatman/operator concerned.**

Neighbourhood Plan Progress Report 10th July 2019

Regulation 15 Neighbourhood Plan

On 4th July 2019 The Bigbury Neighbourhood Plan was formally submitted to South Hams District Council under Regulation 15 of the Neighbourhood Planning (General) Regulations 2012. As well as the Neighbourhood Plan, the following documents were also submitted:

- A map showing the extent of the Bigbury Parish, which is the area to which the proposed neighbourhood plan relates;
- A consultation statement;
- The proposed Neighbourhood Development Plan;
- Statement explain how the proposed development meets the requirements of paragraph 8 of Schedule 4B of the 1990 Act (Basic Conditions Statement);
- Strategic Environmental Assessment (SEA) for the Bigbury Neighbourhood Plan, Environmental Report prepared by AECOM.

A copy of the Plan and these documents has also been placed on the community website. A link to all of the documents has been placed on the Bigbury Drums website and will be placed in the next edition of the Bigbury News. One hard copy of the Plan has also been placed in the Holywell Stores.

The next stage is for SHDC to do a final check of the plan. SHDC will then carry out a further consultation of the Plan and an Inspector, to consider whether the Plan meets all of the statutory requirements, including being in accordance with the Joint Local Plan, will then be appointed.

If the Plan is approved by the Inspector, with or without further amendments, it will then go to a referendum where the community will be given an opportunity to vote on whether they would like the Plan to be adopted.



I am emailing to introduce myself and ask whether you think the residents of Bigbury would be interested in having a 'roadshow' event from us at South Dartmoor Community Energy (SDCE) this Autumn/Winter. We are a not-for-profit community energy organisation based in Ivybridge and work across the South Hams to offer impartial advice to house holders on ways to save money on their home energy bills and to reduce their carbon emissions. We can provide people with information on grants for heating or insulating their home. During the last three years, we have mainly been delivering energy advice in the larger towns and we'd now like to focus on the smaller parishes.

It is harder to reach people out in the smaller parishes, so I was hoping you may have some ideas on which groups to contact in the parish and what day of the week would be most suitable? We are keen to hold it on a day when most people are already out and about and we could catch them, for example on their way to a coffee morning. On the day, between them our 3 friendly Energy Advisors could give a talk to a community group (eg coffee morning / lunch club) and look at people's energy bills on a 1:1 basis, set up a drop in session in the Memorial Hall and knock on doors to ask people if we can help.

Also, if you know of any people who you think may benefit from our advice, such as people living in fuel poverty, lone pensioners, people with ill health or those keen to use reduce their carbon emissions we could organise some home visits from our Energy Advisors for that day. Home visits could also be arranged at a later date, once we've met people during the roadshow.

Before the roadshow day we would promote the event by using posters, articles in the local newsletter and local paper, advertising on local social media pages and letting local groups know.

We are also asking Parish Councils across the South Hams if they are interested in looking at ways for their Parishes to become carbon neutral. If this applies to you, please let me know. If there is enough interest, SDCE could organise a workshop for Parish Clerks/Council Reps to listen to speakers and work together to discuss ideas and make plans.
